1. Hosting the prestigious 16th World Congress of Accountants 2002
  2. Revision to rebranding and membership change proposals, to be put to the vote in an Extraordinary General Meeting
  3. Concluded discussions reaching reciprocal membership agreements with the six Chartered Accountancy Institutes
  4. Implemented new standard setting strategy of due process convergence with international accounting, auditing and assurance and ethical standards, guidelines and codes
  5. Became founder member of the International Innovation Network, an initiative to facilitate development and sharing of new products and services in the international market
  6. Taking part in the work of the international consortium that developed the international taxonomy for XBRL, a worldwide standard for financial reporting on the Internet. Working on a taxonomy for Hong Kong GAAP
  7. Clarified the state of local profession with a Post-Enron statement presented to the Legislative Council Panel on Financial Affairs in a special meeting on initiatives to strengthen Hong Kong's corporate governance regime
  8. Accelerated changes to the practice review process, adopting an enforcement rather than educational approach and working towards using a risk-based rather than cycle-based approach to practice unit selection

  3. 與六家特許會計師公會達成相互會籍認可協議

  5. 成為專業創新國際互聯組織的創辦成員。此組織的宗旨是促進國際市場上開發和交流創新的產品與服務

  8. 加快完備執業審核過程，由以教育性質為本改為以監管性質為本，並將採納由循環審核模式改為按風險因素來選擇審核執業單位的模式

  10. Introduced voluntary adoption of revised practical experience requirements for prospective members under an Authorised Employer and Authorised Supervisor scheme

  13. Increased activities of Small and Medium Sized Practitioners Committee adding greater value to small and medium sized practices
  14. Formed a Task Force on PRC Corporate Governance with co-operative links with the China Securities Regulatory Commission
