OFFICIAL RECEIVER'S OFFICE CIRCULAR NO. 5/2014

**Applications for Appointment of Provisional Liquidators under section 193
of the Companies (Winding Up and Miscellaneous Provisions) Ordinance (Cap. 32)**

The Official Receiver's Office ("ORO") is often given short notice of hearings for the appointment of provisional liquidators under section 193 of the Companies (Winding Up and Miscellaneous Provisions) Ordinance (Cap. 32) (formerly titled as the Companies Ordinance (Cap. 32) before 3 March 2014).

2. To allow the ORO lawyer to prepare for and attend the hearing, please notify the ORO as soon as a decision to make such an application is made. An initial phone call to our Ms. Fiona Lee, Assistant Official Receiver (Legal Services) on 2867 2457 (or her secretary on 2867 2506) and delivery of draft papers prior to formal service would be of considerable assistance as in most cases, the final papers are often only available at the court hearings. This would avoid the possibility of the court having to consider adjourning the hearing pending a response from the ORO.

3. Your co-operation in this matter is appreciated.

4. Official Receiver's Office Circular No. 1/2014 dated 2 January 2014 is cancelled and is superseded by this circular with immediate effect.
