Module D (taxation)

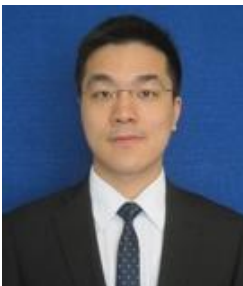
