# Route to success with QP

## When and why did you decide to pursue a career as an accountant?

I became interested in accounting when I was studying at the secondary school. I enjoyed applying logical thinking in everyday life, such as analysing companies, their potential risks and ways to improve their business. I therefore decided to major in accounting at the City University of Hong Kong. I felt that a career in accounting could be very rewarding as I could help the companies to turnaround their businesses.



## What experience did you gain in your previous job?

My first job was at PricewaterhouseCoopers (PwC) and my second employment was with Amoy Food (HK) Ltd.. The most valuable experience I gained at PwC was the opportunity to work with listed clients. I was exposed to varied areas such as compliance and internal control. As I had to deal with different levels of people at these big companies, both my technical and interpersonal skills were greatly enhanced. My next job was at Amoy Food (HK) Ltd. as the Assistant Business Planning Manager. In that capacity, I had to take up more responsibilities and to work independently, which enabled me to develop my experience and skills further.

## How did you hear about QP?

I heard about QP while I was at university. The Hong Kong Institute of CPAs organized talks and exhibitions on campus and we were provided with detailed information about the programme.

## What made you decide to enrol in QP?

I decided to enrol in QP as I found it a very comprehensive and practical programme. It covered training of both technical and generic skills, which I believed were essential for my career development in the accountancy profession.

## What parts of QP did you find the most interesting or useful?

I found the workshops most useful. In each workshop, we were encouraged to think creatively, and to discuss and share views with other QP students. They were tailor made and updated frequently, providing us with the most current standards and guidelines in the areas of financial reporting, auditing and taxation.

#### How did you find your current job with Win Hanverky Holdings Limited?

Win Hanverky Holdings Limited is a sportswear manufacturer and distributor. My current duties include financial reporting and accounts monitoring of its subsidiaries. I enjoy my current job and learn a lot from it. I find it very challenging and good for my professional development.
