# HKICPA seminar: Advance Rulings - Decline and Fall?

Programme Code: TFP151201S

Advance Ruling ("AR") applications are submissions made to the Inland Revenue Department ("IRD") asking it to decide how tax law will apply to the specified arrangement or transaction. Such decision from IRD can provide applicants with Hong Kong tax implications on that specified arrangement or transaction before it is implemented. In this seminar, the speaker will provide an overview of AR including its background, function, relevant statutory rules under the Inland Revenue Ordinance, and the administrative process. In addition, he will also highlight the following topics:

- The issues: Limitations of the AR system and recent developments.
- Administrative delays and costs: An anonymised summary of certain recent experiences with the AR regime and the potential pitfalls for both practitioners and clients. When will be a good timing to withdraw an AR?
- What do you do with an unfavourable AR decision? Consideration of the legal and practical consequences of an adverse AR. Is judicial review a solution?
- Do we still need AR? Explore alternatives to applying for an AR and rethink tax litigation at the Board of Review as a potential solution or hedge against the uncertainty of the AR regime.
