



## HKICPA seminar: **Presentation of Cases before Inland Revenue Board of Review and Review of Recent Cases and Developments**

The Board of Review ("BOR") is an independent statutory body constituted under the Inland Revenue Ordinance to hear and determine tax appeals. A taxpayer must fulfill certain requirements to lodge a valid appeal to the BOR. The BOR shall, after hearing an appeal, confirm, reduce, increase or annul the assessment appealed against, or may remit the case to the Commissioner of Inland Revenue for re-assessment.

In this seminar, the speaker, a former member and one of the deputy chairmen of the BOR, will talk about what a taxpayer needs to pay attention to in presenting a case before the BOR, and review recent BOR cases and developments.
