# Experience Sharing on Environmental, Social and Governance (ESG) Reporting

In the year 2000, the Institute first launched the Best Corporate Governance Disclosure (BCGD) Awards to honour locally-listed companies and public sector/not-for-profit organizations that exemplify the best corporate governance standards in Hong Kong, as reflected in their annual reports. The BCGD Awards remains Hong Kong's most prestigious awards for corporate governance.

Starting from October 2015, the Institute is going to launch the BCGD Awards Series of seminars to enable our members to engage with the BCGD Awards winners on corporate governance and related subjects.

The Hong Kong Stock Exchange (HKEx) has been spending tremendous efforts to improve Hong Kong's standards of corporate governance. In particular, HKEx seeks to strengthen the requirements on Environmental, Social and Governance (ESG) disclosure through its recommended best practices of ESG reporting (Appendix 27 of the Hong Kong Listing Rules), some of which are expected to be raised to the level of "comply or explain" in future.
