#### **Course outline**

It also supports organizations as they adapt to the pace of a changing business environment, manage risks to acceptable levels and improve the reliability of information for decision-making. In this seminar, we not only pinpoint the key changes to the Framework, but also show you a case study with a few easy steps for developing and executing the COSO Transition Plan. Some frequently asked questions on the COSO transition will also be addressed.
