## **Real Challenges of China Tax Resident Enterprise Rules**

The relevant rules of China tax resident enterprise are not new as stipulated in the China Enterprise Income Tax Law effective from 1 January 2008. However, people are unfamiliar with their challenges on tax compliance practice, business operations and investment structuring. Recently, attention was drawn to a tax case whereby a foreign company was re-characterized as a China tax resident enterprise, which rendered the disposal of its shares to become taxable in China. The speaker will revisit the relevant provisions and their applications in recent years, as well as to analyze the potential implications and to suggest necessary improvements to mitigate risk on non-compliance.
