IFRS 7 requires additional disclosures on the credit risk, market and liquidity risk of financial instruments, while IFRS 13 applies credit value adjustment on financial assets. Simple financial instruments can easily have their fair value assessed with observed market prices. However, many complex financial instruments are less marketable, involving higher uncertainty on asset valuation. This seminar will discuss the issues on assessing the fair value, as well as their credit risk, market risk, credit value adjustment and other risk components, of financial assets.
