Cyber security incidents have hit the headlines more frequently in recent years. Despite better cyber security measure, increased reliance on the internet for doing business has led to an increase in the number of cyber security incident, and the extent of its scale and impact. However, how hackers compromise one's computer network remains relatively not well understood.

This seminar aims to provide an understanding on how hackers work to compromise computer networks by demonstrating examples of hacking techniques. The speaker will also discuss how security controls can be effective or ineffective when dealing with different types of cyber attacks.
