HKICPA seminar: New Hong Kong Companies Ordinance: Business Review

On 3 March 2014 the new Hong Kong Companies Ordinance ("New Co") came into effect. One of the new requirements of New Co is that all Hong Kong incorporated companies shall include a "business review" in their annual directors' report unless exempt. This new requirement is first effective for annual reporting periods beginning on or after 3 March 2014 – for example for years ending 31 March 2015.

The purpose of this seminar is to brief members on the key aspects of this new requirement, including giving an overview of the new guidance contained in Accounting Bulletin 5, developed by the HKICPA at the invitation of the Companies Registry. This seminar will also focus on the following key topics:

- Which companies are exempt from this requirement and how to claim exemption?
- What are the requirements of the New Co for those companies that cannot or do not wish to claim exemption? What is expected in practice?
- How will these requirements affect listed companies?
