## HKICPA seminar： <br> Corporate Governance and Development

The HKEx is committed to the highest standards of corporate governance and recognizes that good governance is pivotal in helping business to deliver its strategies whilst generating sustainable shareholder value and meeting its obligations towards shareholders and other stakeholders．

Since the introduction of the Corporate Governance Code in 2005，corporate governance codes，rules and regulations in overseas jurisdictions have evolved and now place greater emphasis on risk management，rather than just on internal controls． The existing Code does not properly reflect this emphasis．

The HKEx published a＂Consultation Paper on Risk Management and Internal Control：Review of the Corporate Governance Code and Corporate Governance Report＂in June 2014，and the conclusion was published in December 2014．The document states the proposed changes to the Corporate Governance Code and Corporate Governance Report（＂Code＂）and the comments from the market．

This seminar aims to provide an overview on the corporate governance environment in Hong Kong and to share practical experiences on adopting the updates．
