About the competition

The competition is divided into two categories: **Cha Cha Cha and Waltz**, both at beginner level. A contestant can join more than one category with different partner.

- This is an amateur competition. Any paid instructor is not eligible to enter into the competition. Members who enter into the competition must neither have entered in any open dancing competition nor taken any dancing examination of the category that they enter.
- There is no fixed choreography or syllabus.
- This is a duo competition. We accept registration from one female and one male; two females or two males.
- Judges will look for members' posture; timing; line; hold; poise; musicality and expression; foot and leg action; lead and follow and floor craft.
- The duration of each dance is approximately 2 minutes.
- The entire competition including prize presentation will take place at the Dance Fun Night on 22 November. First, second and third place will be awarded with trophies/medals.
- Deadline for entry is **3 November 2014**.
- No entry fee is required.
- The competition will be cancelled if there are less than 5 entries. Subject to the final number of entries, the competition may be divided into preliminary and final rounds taking place in the same evening.
