Non-members' applications will only be processed after registration deadline subject to availability. We only consider non-member's enrolment when it is enrolled with a member.
2. Full payment must be made before your enrolment will be processed. No telephone reservation will be accepted.
3. The closing date for enrolment is **29 May 2015**. However, the Institute has the discretion to accept late applications as it sees fit.
4. Application by fax will ONLY be accepted when payment is made by credit card. Cash is strictly NOT accepted.
5. Successful enrollees will receive confirmation 2 working days after the enrolment deadline by email or by telephone whereas unsuccessful applicants will receive full refund by mail.
