- 1. Priority of enrolment will be first offered to DBIG members and then to non-DBIG HKICPA members in the case of over-subscription. Non-members' applications will only be processed after registration deadline, subject to availability. We only accept non-members' enrolment as a guest of a member.
- 2. Full payment must be made before your enrolment will be processed. No telephone reservation will be accepted.
- 3. The closing date for enrolment is <u>4 January 2015</u>. However, the Institute has the discretion to accept late enrolment as it sees fit.
