This year training will begin on 15 March 2015 for 3 months on every Sunday at 9:00 (for 2.5 hrs) at Sai Sha Wan, Sai Kung for 3 consecutive months. Additional training on Wednesday evening may be scheduled at 8:00 pm for 1.5 hrs nearer the race.
