(excluding ferry charge, which will have to be paid by participants on the event day at the Golf Course's Instruction Centre or Reception counter)

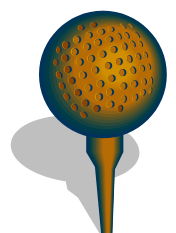
Golf gear: Golf clubs and balls will be provided by Kau Sai Chau on a complimentary basis.
