1. Priority for enrolment will first be offered to GIG members and then to non-GIG HKICPA members in the case of over subscription. Non-members' applications will only be processed after registration deadline if the enrolment is not yet full. We only accept non-members' enrolment as a guest of a member.
2. Full payment must be made before your enrolment will be processed. No telephone reservation will be accepted.
3. The closing date for enrolment is **7 January 2015**. However, the Institute has the discretion to accept late applications as it sees fit.
4. Application by fax will ONLY be accepted when payment is made by credit card or cheque. Cash is strictly NOT accepted.
