

The 11th Recreation and Sports Club for Hong Kong Professional Bodies Golf Tournament 2015

The 11th RSCP Golf Tournament will be held on **Wednesday**, **4 March 2015** at the Jockey Club Kau Sai Chau Public Golf Course, Sai Kung. Other participating professions include architects, dentists, doctors, solicitors and surveyors.

The Institute is recruiting 22 members to form its representative team. Members, whose golf handicap is 24 or below, are welcome to put forward their names for consideration. In the event that there are more than 22 members expressing their interest, an internal selection will be held based on members' handicap, among other things.

To enable the selected teammates to meet up and get to know each other before the tournament, a pre-tournament lunch will be held on **Tuesday, 24 February** at the Institute, 37/F Wu Chung House, 213 Queen's Road East.
