CPA Singing Contest 2014



The much anticipated annual CPA Singing Contest is open for registration. It will not only offer an opportunity for members to showcase their vocal talents, but will also serve as an internal selection process for the Recreation and Sports Club for Hong Kong Professional Bodies Singing Contest. This year we have introduced a new group category. Interested members may enter both the solo and the group category subject to final enrolment.



Come join the singing contest and show us your vocal talents!

Place Tonno Club (1/F, The Tonno, 5 Tonnochy Road, Wanchai, Hong Kong)

Eligible entrants HKICPA members only (no student members for this event)

Maximum capacity Solo entries: 25

Group entries: 5

Awards - Champion, 1st and 2nd runner up for both solo and group category

- Best Stage Appeal (最佳台風獎)

- Most Popular Contestant (最受歡迎歌手獎)

Fees: \$210 (solo entry) \$350 (group entry) \$50 (guest)

[Subject to final enrolment, each contestant may bring up to 2 guests due to venue

constraint.]

Format

- The contest is confined to pop songs to be sung in Cantonese, Putonghua or English.
- To facilitate the identification of the chosen song, contestants are advised to specify the preferred singer of the song that he/she will perform.
- Only MTV version of a song is available for the contest. Concert version is not available.
- Each contestant must provide a copy of the lyrics for judges' reference.
- All contestants, irrespective of the category that they enter, are eligible to be awarded the "Most Popular Contestant" award (最受歡迎歌手獎) and the "Best Stage Appeal" award (最佳台風獎). The former will be voted by the contestants while the latter will be voted by the judges. There will be one winner for each of these awards.

Solo category:

- 1. The preliminary and final round will both be held on 30 November 2014.
- 2. Song selection is subject to availability at the Tonno Club.
- 3. No change of song initiated by contestants will be entertained after the enrolment deadline (28 October 2014).
- 4. A contestant is expected to memorise the lyrics of the song. No visual aids except music are allowed in the entire competition.
- 5. Each contestant will perform one song at his/her choice (subject to availability) in the preliminary round. The maximum score for the song is 60% of the total marks.
- 6. All contestants will be given the list of songs for the final round in advance. Finalists will draw one out of two songs for the category that he/she picks. The maximum score for the song in the final round is 40% of the total marks.
- 7. The top three contestants will be awarded the champion, 1st runner-up and 2nd runner-up.

Group category:

- 1. Each group entry may comprise up to 4 singers.
- 2. There is no final round for group contestants.
- 3. The top 3 group contestants with highest score will be awarded the champion, 1st runner up and 2nd runner up.

Rules

- The duration of the performance should NOT be more than 6 minutes.
- Contestants are not allowed to alter the echo of the microphone for both rounds...
- Finalists are not allowed to change the key of the song.
- Decisions made by the judging panel shall be final and no appeal will be entertained.
- Contestants who breach any of the rules may be subject to disqualification.

Preliminary round:

- 1. Marking scheme:
 - 1.1 A maximum of 60% can be scored by a solo contestant and the remaining 40% at the final round
 - 1.2 A maximum of 100% can be scored by group contestants
- 2. The preliminary round will determine:
 - 2.1 The 5 solo contestants with the highest scores to enter into the final round
 - 2.2 The champion, 1st runner-up and 2nd runner-up of the group category
 - 2.3 The "Best Stage Appeal" award (最佳台風獎)

Final round (solo category only):

- 1. There are two songs in each of the following group that a finalist can draw one to perform in the final round:
 - i. Cantonese male
 - ii. Cantonese female
 - iii. Putonghua male
 - iv. Putonghua female
 - v. English male
 - vi. English female
- 2. All solo contestants will be informed of the song list on or before 5 November 2014.
- 3. The performance sequence will be determined by draw lot.
- 4. Marking scheme: each finalist can get a maximum of 40% of the total scores.
