

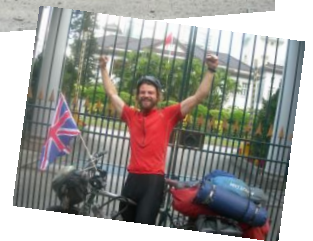
## More than an accountant – a cross-country cyclist odyssey
