**A Guide through IFRS 2011** includes the full text of the Standards and Interpretations and accompanying documents issued by the International Accounting Standards Board as at 1 July 2011 with extensive cross-references and other annotations. This edition is presented in two volume parts, sold together as a set:

Part A (the Conceptual Framework and requirements) contains complete and up-to-date consolidated text, with extensive cross-references and other annotations, of International Financial Reporting Standards (IFRSs), International Accounting Standards, and International Financial Reporting Interpretations Committee and Standing Interpretations Committee interpretations.

Part B contains the accompanying documents, such as illustrative examples, implementation guidance, bases for conclusions and dissenting opinions.

In addition, footnotes describe issues on which the IFRS Interpretations Committee and its predecessor decided not to develop an interpretation.

This edition does not contain documents that are being replaced or superseded but remain applicable if the reporting entity chooses not to adopt the newer versions early.
