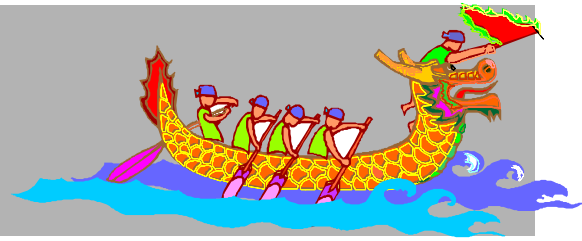




## Dragon Boat Training Course

  - drinking water (at least 1L)
