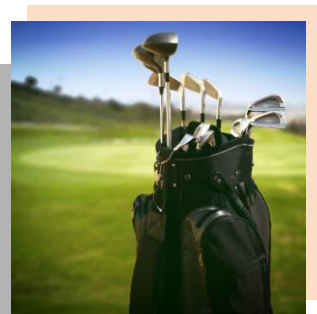




Advanced Short Game Training at Kau Sai Chau

Date: **17 March 2012, Saturday**

Venue: **The Jockey Club Kau Sai Chau Public Golf Course (KSC), Sai Kung**

Contents: Besides skills at roughs or surrounds near greens, the Golf Pro will also cover basic skills in sand bunkers around greens. Key points of the course include:

- understanding variances of different lies
- making correct choices of club
- learning mental thoughts of short games
- adopting appropriate short game skills
