Target participants: Players, have basic golf skills and playing experience, who wish to improve their on course

playing techniques and strategies. (Not intended for first timers and beginners.)

Course contents

- Learn about course management, techniques and strategies.
- ✓ Learn golf etiquette and rules.

Notes

- 1. The event will be cancelled if the minimum enrolment is not met.
- 2. This is a technique coaching session, given the time spent on coaching; it is likely that players cannot finish 18-hole within 4 hours.
- Complimentary use of electric golf cart on a sharing basis (not allowed on fairways or turf areas). Only
 applicable to South Course and East Course, as North Course is a walking course, subject to the golf
 professional's arrangement.
- 4. No caddy will be allowed, except on North Course with the permission of the golf professional.
- 5. Ferry service departs from Sai Kung Pier at 20-minute interval on the clock, 20-min past, 40-min past. Players are recommended to take the 1:00 pm or 1:20 pm ferry (the latest).
- 6. Assemble outside the Golf Instruction Centre (1/F, Administration Building) for registration.
- 7. Participants are requested to bring their own golf gear, similar to playing a normal round of golf (such as golf clubs, golf balls, tees, markers, divot repairing fork, golf shoes, golf gloves, etc.). Complimentary use of KSC golf clubs would only be considered on an exceptional basis. Traditional golf dress code and etiquette apply.
- 8. Complimentary use of locker/changing room facilities.
- 9. KSC policy does NOT give refund for late cancellation and/or no-show after confirmation.
