Calligraphy class (Xing Shu)。 中國書法課程 <mark>行書-《蘭亭序》</mark>

課程內容

東晉大書法家王羲之的《蘭亭序》一直以來被列為天下第一行書,其輝煌的藝術成就是千百年來中國書法的頂峰,王羲之也因此被後人譽為書聖。清新流美的《蘭亭序》更是東晉以來歷代書法家臨摹的第一範本。

本期《蘭亭序》課程共兩期三十堂,第一期十五堂前期會有一些基礎筆法的學習,之後正式臨摹《蘭亭序》,後十五堂會繼續臨摹並適當讓學生以《蘭亭序》為藍本寫些作品。

本班第一期課程共分十五堂,每堂一個半小時,其課程詳情請參閱後頁。

導師履歷

劉才昌先生 一九三六年生,山東榮成人。現為香港中國書法家協會會長,香港中國書法研究所所長,香港美術家協會書法委員會主席,中國書畫函授大學教授。一九五五年考入北京大學,畢業後在大學從事教育工作二十餘年。書畫師從當代藝術大師劉海粟、徐北汀等,書法五體皆擅。其特點:用筆精到,富於韻律,結體嚴謹,流美多變。曾任中國書法家協會會刊<中國書法>編輯,在中國科學院、北京第二外國語學院、北京舞蹈學院、香港浸會學院等多個學院任教,並在北京電視台<書法藝術>專欄和香港電台<神州縱橫>節目中主講書法。其作品入選多届全國書法篆刻展、二十世紀書法大展、中國當代書壇名家作品展及日本、韓國、新加坡等重大國際書法展。



作品入編〈當代中國書法作品集〉、〈當代書法藝術大成〉、〈中國當代著名書法家百人精品集〉、〈全國首届著名作家、詩人、書法家、畫家聯展作品集〉、〈香港名家書法展集〉等專輯。名列〈中國古今書畫名人大辭典〉、〈中國當代書法家辭典〉、〈中國當代書畫家名人大辭典〉、〈中外名人辭典〉、〈香港名人辭典〉、〈中國當代名人錄〉、〈中國當代書畫家傳〉及〈中國美術年鑑〉等。在新華社香港分社工作期間,曾策劃、參與主辦內地和香港美術交流展一百多次。榮獲國內外書法大展金獎二十餘次。除書法創作外,在書法理論方面也多有建樹,其書法論文〈書法理論與創作管見〉榮獲文化部優秀獎。

劉才昌先生還對香港書法教育貢獻良多,桃李滿門。前新華社香港分社社長周南、副社長張浚生及前律政司司長羅德丞、全國政協委員陸達權、簡福飴等均為他的學生。一些學生現在國內外的高等院校任教。香港回歸祖國十週年之際,中國文藝報在隆重介紹香港各界名流中,大篇幅地對其進行了報導。劉才昌先生是中國當代最著名的十大書法家之一,國家級出版社為其編輯經典專輯行世,中國郵政還為他發行了十六張書畫作品專題郵票。
