



CPA Concert & Stage Performance Workshop



CPA Concert is coming! It is one of the most popular events organised by **Singing Interest Group (SgIG)**. There are about 25 performances for the evening. If you wish to gain experience on stage performance, sign up NOW as the performer quota fills up quickly. Performance can be in solo, duo or group singing.

- Date:** Sunday, 12 October 2014
- Time:** 6:30 p.m. – 9:30 p.m.
- Venue:** **Leighton Hill Community Hall (銅鑼灣禮頓山社區會堂)**
 G/F, 133 Wong Nai Chung Road, Happy Valley, Hong Kong
- Performers:** Only Institute members or QP students
- Performance fee:** **\$300** per song (max. 2 songs per unit, subject to final number of enrolments)
- Admission ticket:** **Free** admission on a first-come-first-served basis with priority given to members. Prior registration is required. Uncollected tickets by 9 October will be forfeited and given to audience on waiting list.

Notes for performers

- Registration as a performer is on a first-come-first-served basis.
- Each performer/performing unit (max. 6 in a group) can perform up to 2 songs with each song no more than 5 minutes, subject to the total number of performers.
- No medley or concert versions are allowed.
- In the case of song duplications, involved parties will be asked to reconsider their selections. Once the performing songs are confirmed, no further changes will be entertained.
- NO television screen will be provided during performance.
- Each performer/performing unit is entitled to 10 free tickets.
- All performers are encouraged to join the “*Stage Performance Workshop*” to be led by professional singing teacher (details as below).
- Rehearsal session with live band is scheduled for the evening of **Saturday, 27 September**. All performers **must** attend.

Stage Performance Workshop

- A **free** stage performance workshop will be held on **Sunday, 21 September at 2:00 – 4:00 pm at the Hong Kong Institute of CPAs**.
- Learn from professional singing teacher regarding the do's and don'ts on stage performance and the tips on how to enhance stage presence.
