- 3. Each performing song should not be more than 5 minutes.
- 4. No medley or concert version is allowed.
- 5. In the event of song duplication, involved parties will be invited to re-select their songs. Once the performance songs are confirmed, no further changes will be entertained.
- 6. NO visual aid will be provided during performance.
- 7. Each performer/performing unit is entitled up to 10 free tickets.
- 8. Rehearsal session is available on the same day prior to the concert. Due to limited time available on event day, each performing unit will be given approximately 3 minutes to rehearse.
- All performers are required to attend the rehearsal session with live band on <u>30 August</u>.
- 10. Details of rehearsals will be announced in due course

- 6. Successful enrollees will receive confirmation by email, whereas unsuccessful applicants will receive full refund by mail.
