- 4. The duration of each lesson is also subject to the actual booking. Each lesson will be at least 1.5 hrs and that the total number of hours for the entire course will be 8 hrs.
- 5. Full payment must be made before your enrolment will be processed. No telephone reservation will be accepted.
- 6. The closing date for enrolment is 23 July 2014. However, the Institute has the discretion to accept late applications as it sees fit.
