- Priority for enrolment will first be offered to HKICPA members, who had completed elementary tennis training course organized by the Institute, in the case of over-subscription. Non-members' applications will only be processed after registration deadline subject to availability. We only consider non-member's enrolment when it is enrolled with a member.
- 2. If the number of enrolment is below 8, the class may be cancelled and enrollees will be given full refund.
- 3. Availability of venue will be confirmed by the coach in the <u>preceding Monday</u> subject to venue availability. The dates shown above are for indicative purpose.
- 4. The duration of each lesson is subject to the venue availability. Each lesson will be at least 1.5 hrs and the course will comprise of 8 hrs in total.
- 5. Full payment must be made before your enrolment will be processed. No telephone reservation will be accepted and cash is strictly NOT accepted.
- The closing date for enrolment is <u>24 December 2015</u>. However, the Institute has the discretion to accept late applications as it sees fit.
