

## Listing Rule amendments relating to connected transactions

#### About the topic

Earlier this year, the Stock Exchange of Hong Kong published a number of changes to the Listing Rules in relation to connected transactions, including to the definitions of "connected person" and "associate". The changes aimed to simplify and improve the clarity of the relevant rules and to align definitions in different parts of the Listing Rules.
