

### Become a new QP (Associate Level) Marker and


### reveal the CPA discovery

The Hong Kong Institute of Certified Public Accountants (the "Institute") is now inviting you to be appointed as markers for its Associate Level of new Qualification Programme (the "new QP"). Come and join us to be a part of this important process to reveal the future-ready accountants.

#### What is the new QP?

The new QP provides world-class and comprehensive training to ensure that upon completion, the newly qualified CPAs will be equipped with the necessary technical knowledge, professional skills, values and ethics, and relevant practical experience to meet the needs of employers in today's work environment.

The new QP comprises three progressive levels with 14 modules and a Capstone, i.e. Associate Level (10 modules), Professional Level (four modules) and Capstone. It offers alternative pathways and greater flexibility for students with different educational backgrounds, including sub-degree holders and non-accounting majors, to become CPAs. This could attract more students from different disciplines to join the accountancy profession which is important in developing a sustainable talent pool of accounting professionals.



## Associate Level of the New QP

The Associate Level comprises 10 modules. It aims to provide students with a foundation of core technical knowledge and application skills for routine professional problems in the areas of accountancy, finance, management accounting, law and auditing to enable their progression to the Professional Level.

Relevant Practical Experience

The module examinations will be a three-hour, closed-book examination (except for Module 10 "Business and Company Law" of which the examination will be open-book). The examinations will comprise multiple choice questions and written questions which are all compulsory (excepts for Module 10 "Business and Company Law" in which the examination will only comprise written questions).

Upon successful completion of the Associate Level by exemption or examination, or a combination of both, students are entitled to the exit qualification of "HKICPA Associate Qualification" which is recognized as a Level 5 professional qualification under the Hong Kong Qualifications Framework. In addition, students will be able to advance to the Professional Level of New QP. #### **Role of Markers**

Markers are required to mark the new QP (Associate Level) module examination paper according to the provided marking scheme and specified marking procedures.

### Requirements for Markers

A candidate should meet the following requirements:

- (a) Having a minimum of four years' membership with the Institute;
- (b) Hold or recently held a responsible position in a professional, business, government or academic organisation; and
- (c) Have a working knowledge and have demonstrated technical competence in the module subject matter. However, candidates do not have to be specialists in the topics to qualify.

## Guidelines for Selection of Markers

- (a) Established professional competence;
- (b) Clean disciplinary record, in particular in upholding confidentiality; and
- (c) Attend and successfully complete the trial marking during Information Session.
