To recognize their distinguished results, HKICPA is presenting Outstanding BAFS Student Awards with a cash prize of HK\$300 to each individual.

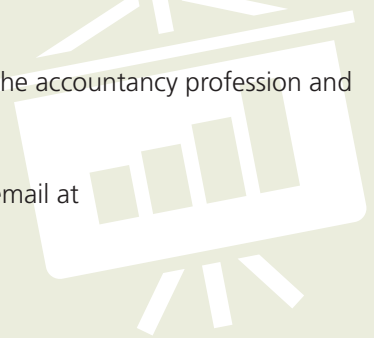

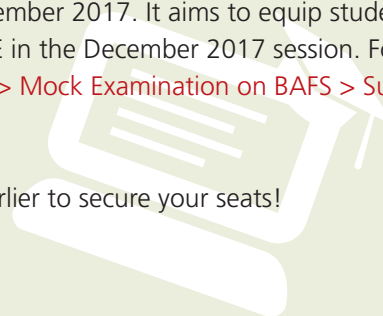

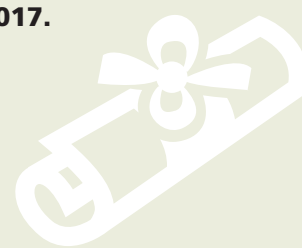


HKICPA/HKABE Joint Scholarships for BAFS 2017-18 calls for nominations

Both HKICPA and HKABE are keen to nurture young talent. The aim of the scholarship is to recognize academic merits; and to encourage senior secondary students to pursue the HKICPA/HKABE BAFS Mock Examination for HKDSE.

The nominations for the 2017-18 scholarship are now open. All secondary schools offering BAFS with an accounting/business management module and with at least one student having enrolled in the HKICPA/HKABE BAFS Mock Examination of that session are eligible for making nomination. Each eligible secondary school may nominate one full-time F.5 student who is studying BAFS accounting/business management module for the scholarship. The nominee shall be the top student in BAFS within the whole form (based on F.4 result), with good character and high participation levels in extra-curricular activities.

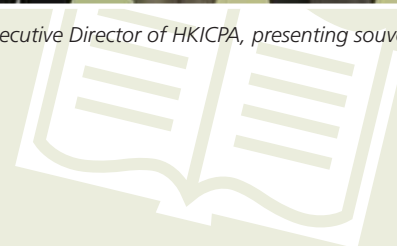
