

HKICPA accounting and business management case competition 2017-18

As one of the flagship events among the secondary schools, the oral presentation of HKICPA accounting and business management case competition 2017-18 was successfully held on 28 April 2018 at the Institute's office. 474 teams and 1,760 students from 111 schools joined in both Level 1 and Level 2 competitions this year. This annual event allows senior secondary school students to apply their textbook knowledge in the areas of accounting and business to the real world. It also enhances students' enabling skills such as analytical thinking, time management, presentation skills, creativity and team building.

This year Hung Fook Tong Group Holdings Limited was the company selected for the case study. Participating teams were required to submit a written business proposal analyzing Hung Fook Tong's business performance and to give a recommendation on strategies to sustain the company's growth. Two business seminars were held earlier in November and December 2017 to help students in preparation for the competition.

Through a blind review of the submitted proposals, the best six teams were selected to enter the final round of the competition—the oral presentation, and compete for the championship.
