

Public Sector Focus Group Discussion – Meeting with the Director of Audit

The professional accountants in business (PAIB) leadership panel has set up different industry focus group gatherings to enable members working in those sectors to mingle and share specific interests and concerns of the field. In the light of discussions at the public sector focus group gathering, the panel has invited the Director of Audit to meet members of the focus group, share insights from the work of Audit Commission and exchange views on financial management and governance in the public sector.

Mr. Benjamin Tang, JP, graduated from the University of Hong Kong. He also studied at the Oxford University and the London Business School. He is a Fellow Member of CPA Australia, an Honorary Member of CGA Canada and a Fellow Member of the Hong Kong Institute of Directors. Mr Tang joined the civil service in 1974 and, after serving various bureaux and departments, was appointed the Director of Audit by the Central People's Government in 2003. Mr Tang has been a member of the Chinese delegation to the congresses of the International/Asian Organisation of Supreme Audit Institutions held in Americas, Asia, Europe and South Africa. He has frequently given speeches at local and international conferences.
