#### ABOUT THE FORUM

The Institute has issued the "Deferred Tax: Recovery of Underlying Assets (amendments to HKAS 12)" on 21 December 2010. An entity shall apply these Amendments for annual periods beginning on or after 1 January 2012 where earlier application is permitted.

The existing HKAS 12 requires an entity to measure the deferred tax relating to an asset depending on whether the entity expects to recover the carrying amount of the asset through use or sale. It can be difficult and subjective to assess whether recovery will be through use or through sale when the asset is measured using the fair value model in HKAS 40 "Investment Property". The Amendments provide a practical solution to the problem by introducing a presumption that recovery of the carrying amount will normally be through sale.

As a result of the Amendments, Hong Kong (SIC) Interpretation 21 "Income Taxes – Recovery of Revalued Non-Depreciable Assets" would no longer apply to investment properties carried at fair value. The Amendments also incorporate into HKAS 12 the remaining guidance previously contained in Hong Kong (SIC) Interpretation 21, which is accordingly withdrawn.
