#### Chungwoo Suh IASB Member

Dr Suh is a Professor of Accounting at Kookmin University, Seoul. He served as an advisor to the Korea Accounting Standards Board (KASB) and as Chairman of the KASB from 2008 to 2011, during which time he led South Korea's preparations to adopt International Financial Reporting Standards (IFRSs) in full from 2011.

Dr Suh has a Ph.D. in Accountancy from the University of Illinois, USA, and an MBA from Seoul National University. He is a Certified Public Accountant in South Korea.



### Takatsugu Ochi IASB Member

Mr Ochi was Assistant General Manager, Financial Resources Management Group of Sumitomo Corporation. He was also a member of the IFRS Interpretations Committee, Secretary-General of the Nippon Keidanren (Japan Business Federation) Taskforce for early adoption of IFRS and an adviser to the Accounting Standards Board of Japan (ASBJ).

He studied Economics at Kobe University, Japan.



#### Henry Rees IASB Technical Director

Henry Rees is a Technical Director at the IASB. In this role, he is responsible for overseeing a number of technical projects and he has been closely involved in the development of the new revenue recognition standard. Before joining the IASB in 2003, he spent 12 years in KPMG's United Kingdom audit practice. He is an English Chartered Accountant and a graduate of Oxford University.
