Grooming future talent

Institute releases consultation paper for the new Qualification Programme in response to changing business environment in Hong Kong and around the world

(Hong Kong, 3 June 2016) – The Hong Kong Institute of Certified Public Accountants releases a consultation paper today on enhancing the CPA qualifying process for the development of the new QP. The purpose of the public consultation is to elicit responses from all stakeholders before the final CPA qualification framework is adopted and the new QP is launched.

According to Ivy Cheung, president of the Institute, QP is an internationally recognized top-quality professional accounting education programme that allows Hong Kong CPAs to practice on five continents. "As part of the Institute's Sixth Long Range Plan objective of ensuring that the programme trains professional accountants with the skills, expertise and ethics to uphold Hong Kong as an international business and financial centre, the CPA qualifying process reform was initiated in 2013," she says.

After two and a half years of consulting with stakeholders from academia, accounting firms, and professional bodies, we have come up with this paper as the basis for our public consultation, adds Cheung.

Proposals for the new QP are built on the best of the existing professional accounting education programme. The new QP has been comprehensively reviewed and deliberately aligned with the relevant International Education Standards of the International Federation of Accountants. The new structure, comprised of three progressive levels with 14 modules and an integrated final examination, offers alternative pathways and greater flexibility for students with different educational backgrounds, including sub-degree holders and non-accounting majors, to become CPAs.

"We believe this could attract more students from other disciplines to join the accountancy profession which is important in developing a sustainable talent pool of accounting professionals," says Raphael Ding, chief executive of the Institute.

He continues, the new QP trains professional accountants to be able to think laterally in identifying complex problems and to provide multifaceted solutions in today's working environment. This way, a Hong Kong CPA designation is an accounting qualification as much as a symbol of business acumen.
