Part 1 - Make your CAB Certificate application

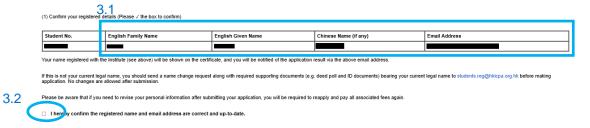
Step 1: Use MyCPA account to login to the <u>e-certificate service</u>



Step 2: Select "Certificate Application" and then click "New Application"



Step 3: Check and confirm your personal information is up-to-date

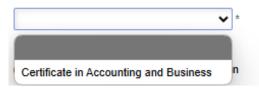


Notes

- Your name registered with the Institute will be shown on the certificate, and you will be notified of the application result via the email address displayed on the form.
- Make sure your registered details are correct and up-to-date before submission.
- You will need to re-apply and pay the associated fee(s) if you wish to amend the registered details after submission.

Step 4: Select the relevant certificate from the scroll down menu

Step 6: Be prepared to pay via VISA, MasterCard, UnionPay, Alipay (China/ Hong Kong) or WeChat Pay (unless waived)

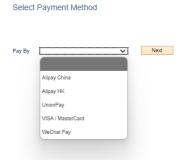

Step 8: Complete the payment process



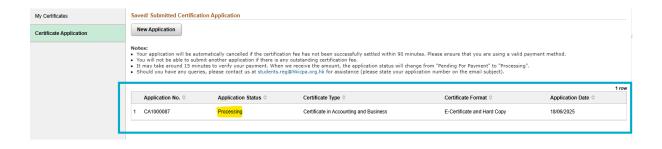

Part 2 - Check your application status

Step 1: Check our email notification (<u>students.reg@hkicpa.org.hk</u>) to ensure successful submission.

In normal case, application status will be changed from "Pending For Payment" to "Processing" after 15-20 minutes.



Part 3 - Earn your CAB Certificate

Step 1: To access your e-Certificate, log-in to the <u>e-certificate service</u> after receiving our email notification (<u>students.reg@hkicpa.org.hk</u>).

Remark:

You are recommended to use a computer for the best viewing and download experience.

If accessing via mobile, please ensure pop-ups are enabled to view the certificate.

For iOS (Apple) users:

To adjust settings:

- 1. Open the **Settings** app on your device
- 2. Scroll down and tap Safari
- 3. Turn off Block Pop-ups



For Android users: No additional settings are required.

Step 2: After login, select "**My Certificate**" and then click "**View**" to view and download your CAB Certificate (PDF file).

For hard copy requests, you will have to collect the certificate at the Institute's service counter in Hong Kong.

Part 4 - Verify the CAB Certificate

Subject to your proper authorisation, employers and HR professionals can verify the validity of your CAB Certificate by entering the details (e.g. the name of CAB holder, a unique certificate number) via online verification services.
