CMHHK Introduction :

The Chinese Medicine Hospital of Hong Kong (CMHHK) is a flagship Chinese Medicine (CM) institution in Hong Kong. As the first CM service-predominant hospital, it offers clinical services through three distinctive approaches: Pure CM Services, Services with CM playing the predominant role and Integrated Chinese-Western Medicine (ICWM) Services. It also serves as the CM teaching hospital for three local universities.

In the first year, CMHHK provides outpatient and day-patient services and fully launches six specialised CM services, namely Internal Medicine in CM, External Medicine in CM, Gynaecology in CM, Paediatrics in CM, Orthopaedics and Traumatology in CM, and Acupuncture and Moxibustion in CM. It provides more than 10 special disease programmes including those for chronic pain, functional digestive disorder and stroke rehabilitation.
