## INVITATION TO COMMENT ON INTERNATIONAL ETHICS STANDARDS BOARD FOR ACCOUNTANTS ("IESBA") **EXPOSURE DRAFT PROPOSED QUALITY** MANAGEMENT-RELATED CONFORMING AMENDMENTS TO THE CODE

The Ethics Committee of the Hong Kong Institute of Certified Public Accountants is seeking comments on the IESBA Exposure Draft which has been posted on the Institute's website at:

The proposal aims to align the International Code of Ethics for Professional Accountants (including International Independence Standards)(the "Code") with the International Auditing and Assurance Standards Board's (IAASB's) suite of quality management standards, especially ISQM 1, Quality Management for Firms that Perform Audits or Reviews of Financial Statements, or Other Assurance or Related Services Engagements and ISQM 2, Engagement Quality Reviews, through conforming amendments so that the Code is consistent and interoperable with these IAASB standards. The review has encompassed the recent revisions to the Code pertaining to Role & Mindset and the Non-assurance Services and Fee-related provisions of the Code.

The Ethics Committee welcomes comments on all matters addressed in the Exposure Draft, but especially those identified in the Request for Specific Comments as set out in Section V Guide for Respondents of the Explanatory Memorandum to the Exposure Draft.

The Ethics Committee invites your comments on the Exposure Draft by 5 September **2021** to allow your comments to be considered in developing its response to the IESBA. Comments should be supported by specific reasoning and should be submitted in written form.
