

# AUDIT PRACTICE MANUAL

(2016 edition) - Update 2020

The Audit Practice Manual (APM) 2020 update kit provides updates to the 2016 edition. A more detailed risk assessment process is now incorporated for auditing accounting estimates in accordance with HKSA 540 (Revised) Auditing Accounting Estimates and Related Disclosures.

### Features of the APM 2020 update kit:

- Overall audit approach including risk assessment of the APM remains the same

  - HKICPA Code of Ethics for Professional Accountants (revised 2018)
  - HKSA 250 (Revised) Consideration of Laws and Regulations in an Audit of Financial Statements and the changes in respect of non-compliance with laws and regulations (NOCLAR)
  - HKSA 540 (Revised) Auditing Accounting Estimates and Related Disclosures
  - The new and amended financial reporting related provisions in the Companies (Amendment) (No. 2) Ordinance 2018
  - HKFRS 16 Leases
  - $\blacksquare$  Additional considerations in respect of going concern arising from COVID-19
