 Contestants will be divided into groups and matches will be conducted in

round robin for preliminary round. Thereafter, the playoffs will be by single knock out. The number of matches varies according to the number of

contestants for the event.

There will be five games of 11 points in each match; and the contestant who

wins 3 games first will win the match.

• The match format may vary subject to the final number of contestants.

Awards: Champion and 1st, 2nd and 3rd Runner-up for each event
