**Venue\*:** South China Athletic Association  
(88 Caroline Hill Road, Causeway Bay, Hong Kong)

**Eligible player:** HKICPA members only (no student members allowed)

**Events:**

- Men's Singles, Women's Singles, Men's Doubles, Women's Doubles and Mixed Doubles
- An event will only proceed if there are at least 4 contestants or 4 teams in the case of doubles
- The maximum number for each event is 32 contestants or 16 teams, subject to change based on the final enrolments
- Each contestant can join up to three events

**Match format:**

- Contestants will be divided into groups and matches will be conducted in round robin for preliminary round. Thereafter, the playoffs will be by single knock out. The number of matches varies according to the number of contestants for the event.
- There will be five games of 11 points in each match; and the contestant who wins 3 games first will win the match.
- The match format may vary subject to the final number of contestants.

**Awards:** Champion and 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Runner-up for **each event**

**Admission Fee:** \$60 for ONE event; \$80 for more than one event
