What is Neuro-linguistic Programming (“NLP”)?

Originally developed by Richard Bandler, John Grinder and others in the 1970s, NLP facilitates positive changes, creates a facet for effective communication with stakeholders at work and explores potential resources and opportunities to create a future that professionals and business managers always want.

Neuro	Understand the thinking mind and processing system of self and others
Linguistic	Use of verbal and non-verbal language to package the message we want to communicate
Programming	Discover and utilise the self and others’ formula of success
