HKICPA Examination in BAFS (December 2016 / January 2017 session) Early-bird offer is now open for enrolment

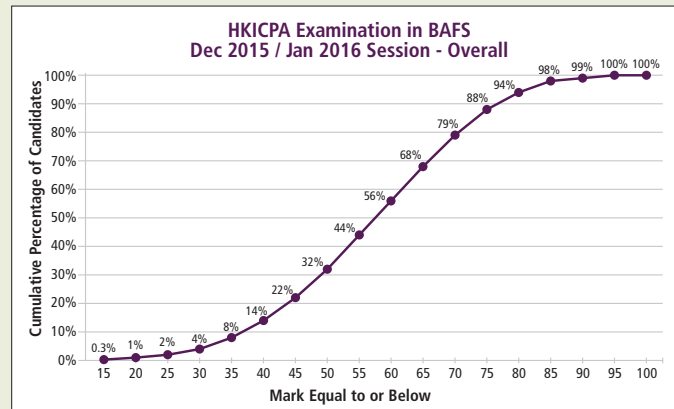
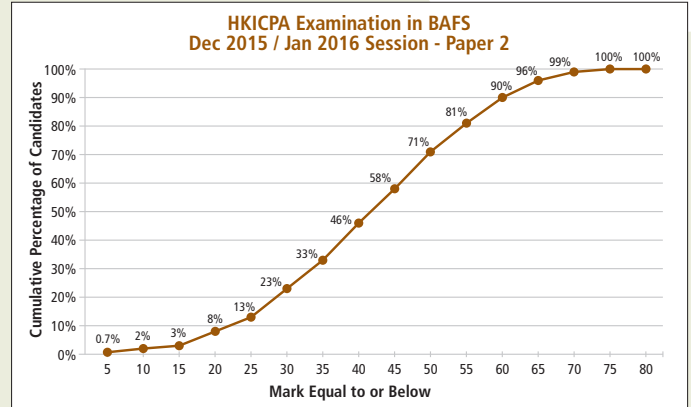
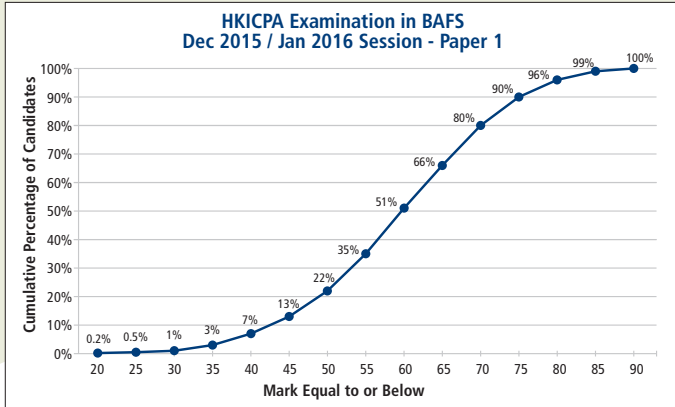




HKICPA Examination in BAFS

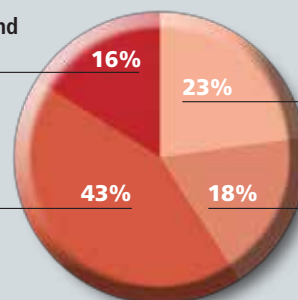

The HKICPA accounting & business management case competition 2015-2016 business seminars on 23 and 29 December 2015
