「一帶一路」和「亞洲基礎設施投資銀行」 與香港未來發展的關係

公 會今年新推出的會員發展活動之一，是舉辦《時事系列研討會》，鼓勵會員了解當前社會的廣闊議題，包括影響營商環境及港人生活的重要經濟措施、大型基建項目等等，並期望能以我們會計師的專業角度，參與相關的討論。

系列研討會的第一炮，是探討近期焦點的「一帶一路」和亞洲基礎設施投資銀行。國家主席習近平提出共建「絲綢之路經濟帶」和「21世紀海上絲綢之路」（一帶一路）的重大倡議，得到國際社會高度關注。「一帶一路」貫穿亞歐非大陸，覆蓋全球超過六成人口，建議旨在促進沿線各國經濟繁榮與區域經濟合作，加強不同文明交流互鑒；習近平主席亦倡議籌建亞洲基礎設施投資銀行（亞投行），按照多邊開發銀行形式和原則營運，促進地區互聯互通建設和經濟一體化進程，向包括東南亞國家聯盟在內的發展中國家的基礎設施建設提供資金。

此首個系列研討會將於2015年6月22日（星期一）舉辦，由外交部駐香港特別行政區特派員公署副特派員擔任演講嘉賓，講述「一帶一路」和「亞投行」這些新舉措與香港未來發展的關係。
