陳文鴻博士於 1992 年至今為香港理工大學中國商業中心主任，並於 2010 年兼任香港理工大學公共政策研究所所長。

1992 年為世界銀行顧問；1994 至 1997 年為中國政府的港事顧問；2003 至 2009 年為香港中央政策組珠三角研究小組成員，並曾擔任香港政府新機場諮詢委員會委員及香港規劃遠景及策略研究小組專家顧問。2013 年 2 月開始為香港特區政府中央政策組特邀顧問。現為中華人民共和國商務部經貿政策諮詢委員會委員。

近年研究重點為中國的發展戰略，從歷史、全球化以至地區和產業，並從中國出發，聯繫至中國與歐洲發展的比較，以及東亞地區的產業和經濟競合。目前的研究課題包括珠三角的生物科技產業發展、珠三角都會區發展、軌道交通與都市發展、市區重建和城市規劃的可持續發展等，以及中國對外的經濟發展(涵蓋東亞、東南亞等地區)。
