近年研究重點爲中國的發展戰略,從歷史、全球化以至地區和產業,並從中國出發,聯繫至中國與歐洲發展的比較,以及東亞地區的產業和經濟競合。目前的研究課題包括珠三角的生物科技產業發展、珠三角都會區發展、軌道交通與都市發展、市區重建和城市規劃的可持續發展等,以及中國對外的經濟發展(涵蓋東亞、東南亞等地區)。
